1. INTRODUCTION

These Terms and Conditions (“**Terms**”) govern the *Refer a Friend* promotional campaign (the “**Campaign**”) offered by **Sky Links Capital** (the “**Company**”, “**we**”, “**us**”, or “**our**”). Participation in the Campaign constitutes the participant’s full and irrevocable acceptance of, and agreement to be bound by, these Terms. The purpose of the Campaign is to provide a promotional incentive to eligible existing clients of Sky Links Capital (each, a “**Referrer**”) who successfully refer eligible new clients (each, a “**Referred Friend**”) to open a trading account with Sky Links Capital and meet the activity and verification requirements as set forth herein. By participating in this Campaign, both the Referrer and the Referred Friend expressly acknowledge and agree to be bound by these Terms and Conditions in their entirety.

2. DEFINITIONS

For the purposes of these Terms and the Campaign, the following definitions shall apply:

“**Referrer**” means an existing client of Sky Links Capital who refers a prospective client to the Company for the purpose of opening and utilizing a trading account, in accordance with the eligibility and participation criteria set forth herein.

“**Referred Friend**” means a new client who has been referred by a Referrer, who has successfully completed the Company’s onboarding and verification procedures, and who satisfies all applicable eligibility requirements prescribed under these Terms.

“**Qualifying Deposit**” means a minimum initial deposit of United States Dollars One Hundred (**USD 100/-**) made by the Referred Friend into the designated trading account with the Company.

“**Qualifying Trading Volume**” means the execution of a cumulative trading volume of no less than **one hundred (100) standard lots** by the Referred Friend, using the trading account established with the Company, within the specified timeframe outlined by the Company.

“**Reward**” means the monetary compensation, benefit, or incentive made available to the Referrer and/or the Referred Friend upon the full and timely satisfaction of all Campaign criteria, as further detailed under Clause 9 (Reward Details) of these Terms.

3. ELIGIBILITY

Participation in the Campaign shall be subject to the following eligibility criteria, each of which must be met in full:

3.1 The Referrer must possess a verified, fully onboarded, and active live trading account with Sky Links Capital at the time the referral is made.

3.2 The Referred Friend must be a new client who has not previously opened, held, or maintained a live trading account with Sky Links Capital or any of its affiliates, subsidiaries, or associated entities.

Sky Links Capital Limited is a Limited Company with Investment Dealer (Full Service Dealer excluding Underwriting) under License No. GB24202837 and is authorized and regulated by the **Financial Services Commission (FSC)** in Mauritius.

3.3 Both the Referrer and the Referred Friend must successfully complete the Company's standard client onboarding and due diligence procedures, including, without limitation, all required Know Your Customer (KYC) verifications and any additional account maintenance requirements as may be imposed by Sky Links Capital in accordance with applicable regulatory obligations.

3.4 All participants in the Campaign must be natural persons who are at least eighteen (18) years of age, or of the legal age of majority in their respective jurisdiction of residence, whichever is higher.

3.5 The Referred Friend must satisfy the Qualifying Deposit and Qualifying Trading Volume conditions as defined in Clause 2 of these Terms for either party to become eligible to receive any Reward under the Campaign.

4. KNOW YOUR CUSTOMER (KYC)

4.1 Participation in the Campaign is contingent upon the successful completion of the Know Your Customer (KYC) process, which shall be conducted in accordance with applicable international regulations and Sky Links Capital's internal policies and procedures.

4.2 Sky Links Capital reserves the right to request additional documentation or information from any participant at any stage of the Campaign, including but not limited to verification of identity, source of funds, and any other relevant details as necessary to comply with applicable regulatory requirements or internal due diligence procedures.

5. HOW TO PARTICIPATE

5.1 Referral Process for Referrers: To participate in the Campaign, the Referrer must use their unique referral link, which is provided through the Sky Links Capital Client Portal, to invite new prospective clients (the "Referred Friends") to open a live trading account with Sky Links Capital. Referrers may invite an unlimited number of Referred Friends to participate in this Promotion. However, each referral must meet all the eligibility and participation requirements set forth herein in order to be considered valid.

5.2 Requirements for the Referred Friend: In order for a **Referred Friend** to qualify for participation in the Campaign and to trigger any entitlement to a Reward under these Terms, all of the following conditions must be fully satisfied:

5.2.1 The Referred Friend must open a new, live trading account with **Sky Links Capital** by using the unique referral link generated by the Referrer. This must constitute the Referred Friend's first-ever trading account with **Sky Links Capital** or any of its affiliates, subsidiaries, or associated entities. Any pre-existing account will render the referral ineligible.

5.2.2 The Referred Friend must complete all mandatory onboarding procedures, including successful completion of the **Know Your Customer (KYC)** process, which includes identity verification, anti-money laundering checks, and other regulatory compliance measures as required by Sky Links Capital and applicable international standards.

5.2.3 The Referred Friend must make a **Qualifying Deposit** of at least USD 100 into their trading account. This deposit must be received and confirmed by Sky Links Capital before the participant can progress toward earning rewards.

5.2.4 The Referred Friend must execute a **Qualifying Trading Volume** of at least 100 standard lots within a **90-day period** starting from the date the first deposit is made into their trading account. The trading activity must be conducted in accordance with the Company's trading policies and the terms set out in these Terms and Conditions.

5.3 Completion of the Referral Process: For a referral to be deemed valid and for any associated reward to become payable, the referral process must be fully completed in accordance with the following requirements:

5.3.1 The Referrer must use an approved method (referral link or designated form) to refer the Referred Friend.

5.3.2 The Referred Friend must fulfill the conditions stated in Clause 5.2 above, including the opening of a new account, completion of KYC, making the Qualifying Deposit, and meeting the minimum trading volume.

5.3.3 Both the Referrer and Referred Friend must comply with all terms and conditions of this Campaign. Failure to meet any of the eligibility or participation requirements will result in disqualification from the Campaign, and no reward shall be issued.

5.4 Tracking and Verification of Participation: All participants in the Campaign agree that their participation and the referral process will be tracked through the Company's Client Portal and verified in accordance with the Company's internal procedures. Sky Links Capital reserves the right to investigate and validate any referral or trading activity, and may, at its discretion, disqualify any participant or referral that does not comply with the Terms or that exhibits suspicious activity.

6. REWARDS DETAIL

6.1 Eligibility for Rewards: Subject to the full compliance with these Terms and Conditions, both the Referrer and the Referred Friend shall become eligible to receive a reward (the "Reward") upon the fulfillment of all conditions outlined in these Terms, including but not limited to the completion of the qualifying deposit, trading volume, and the execution of all onboarding requirements by the Referred Friend.

6.2 Reward Calculation and Amount: The specific reward amount payable to both the Referrer and the Referred Friend shall be determined by Sky Links Capital based on the following factors:

- a) The amount of the Qualifying Deposit made by the Referred Friend; and
- b) The total trading volume achieved by the Referred Friend within the Referral Period as defined in Clause 5.

The Reward shall be subject to the conditions set forth herein and shall be calculated in accordance with the Company's reward structure. However, in no event shall the total Reward payable to any Referrer exceed United States Dollars Ten Thousand (USD 10,000) per Referrer over the entire duration of the Campaign.

6.3 Tiered and Variable Reward Structure: Sky Links Capital reserves the right to introduce a tiered or variable reward structure and to adjust or modify the Reward amounts at its sole discretion. These changes may be based on factors such as trading volume, account activity, geographical location, regulatory considerations, or other relevant factors. Such modifications shall take effect immediately upon being made available through the Client Portal or official communication channels of Sky Links Capital. Participants are deemed to accept such modifications upon their continued participation in the Campaign.

7. PAYMENT OF REWARDS

7.1 Eligibility Confirmation and Reward Disbursement: Subject to the successful completion of all qualifying requirements as set out in these Terms and the Company's internal verification process, both the Referrer and the Referred Friend shall be eligible to receive their respective Rewards. Rewards will be processed and paid within thirty (30) business days from the date of confirmation that all eligibility criteria have been met, including, without limitation, the Referred Friend's successful onboarding (including KYC verification), the deposit of a Qualifying Deposit of at least USD 100/-, and the execution of at least 100 standard lots of trading volume, as set forth in Clause 5.

7.2 Internal Compliance and Verification: All Reward payments are contingent upon the successful completion of Sky Links Capital's internal compliance and anti-fraud verification procedures. These procedures may include, but are not limited to, review and verification of trading activity, client account status, KYC documents, and adherence to applicable legal and regulatory standards. The Company reserves the right to conduct additional due diligence and may request further documentation at its discretion.

7.3 Suspension, Withholding, and Denial of Rewards: Sky Links Capital reserves the exclusive right to withhold, suspend, or deny the payment of any Reward in the event that there is any indication or suspicion of:

- a) Fraudulent activity or attempts to manipulate the Campaign's terms;
- b) Non-compliance with these Terms and Conditions or the Company's internal policies;
- c) Violation of applicable laws or regulatory requirements;
- d) Any breach of the Company's trading policies, including but not limited to market manipulation, wash trading, or any other prohibited activities under these Terms.

7.4 No Interest or Compensation for Delay: In the event of a delay or suspension of Reward payments, Sky Links Capital shall not be liable for any loss, damages, or interest arising from such delay. No compensation shall be provided for any delays attributable to regulatory reviews, compliance checks, client-side verification issues, or any event of force majeure.

7.5 Non-transferability and Non-exchangeability of Rewards: Rewards granted under this Campaign are strictly non-transferable, non-exchangeable, and may not be redeemed for any alternative benefit or consideration, unless expressly permitted by Sky Links Capital in writing. The Reward is solely intended for the eligible Referrer and Referred Friend as determined in accordance with the terms of this Campaign.

7.6 Dispute Resolution and Finality of Decisions: Any concerns, queries, or disputes regarding Reward eligibility, entitlement, or the calculation of Rewards must be submitted to Sky Links Capital in writing within thirty (30) calendar days from the expected disbursement date. In such cases, Sky Links Capital's decision shall be final, binding, and conclusive. The Company shall not be obligated to entertain any claims or disputes submitted after the expiration of the thirty-day period.

8. CAMPAIGN EXPIRY AND VALIDITY

8.1 The "Refer a Friend" campaign shall automatically expire on 30 November 2025 (the "Campaign Expiry Date"), unless extended or terminated earlier at the sole discretion of Sky Links Capital.

8.2 Any referral submissions made after the Campaign Expiry Date shall be deemed ineligible, and neither the Referrer nor the Referred Friend shall be entitled to claim or receive any reward in respect thereof.

8.3 Sky Links Capital LLC shall not be obligated to provide notice prior to the Campaign Expiry Date. However, any decision to extend, amend, or terminate the campaign before the stated expiry shall be published on the Company's official communication channels, including its website.

8.4 The Company reserves the right to reject any referral, withhold payment, or revoke any reward in cases where the referral is submitted after the Campaign Expiry Date or fails to meet the applicable eligibility and verification criteria as set out in these Terms and Conditions.

9. CONDITIONS AND RESTRICTIONS

9.1 Prohibited Conduct: Participation in this Campaign is subject to strict adherence to ethical conduct and regulatory compliance. The following actions are expressly prohibited and shall result in immediate disqualification from eligibility for Rewards

a) Self-referrals: Referrers may not refer themselves under any circumstance. This includes but is not limited to, the use of alternate email addresses, identities, or trading accounts.

b) Duplicate or Fraudulent Accounts: Creation or use of multiple, fictitious, or fraudulent accounts, whether by the Referrer or Referred Friend, is strictly forbidden.

c) Same Household Referrals: Referrals made between individuals residing within the same household, as determined by IP address, physical address, or other identifying information, are not eligible for Rewards.

d) Misleading Promotion: Use of deceptive, misleading, or unauthorized marketing methods, including false representations or high-pressure tactics, is not permitted.

e) Automated or Unethical Methods: Engagement of bots, scripts, or other automated means, or any unethical strategies to generate referrals or manipulate trading activity, will result in disqualification.

f) Regulatory Violations: Any activity in contravention of applicable local or international laws, including but not limited to financial services regulations, anti-money laundering (AML) laws, or securities laws, will render participants ineligible.

9.2 Eligibility Restrictions: Each Referred Friend may only be referred once throughout the duration of the Campaign. Referrals submitted by multiple Referrers for the same individual shall be deemed invalid. Sky Links Capital reserves the exclusive right to determine the validity of any referral and to attribute it based on its records.

9.3 Account Standing Requirement: Both the Referrer and the Referred Friend must maintain their respective Sky Links Capital accounts in good standing for the entire duration of the Referral Period. Accounts that are suspended, closed, under investigation, or deemed non-compliant at any stage shall forfeit eligibility for any associated Rewards.

9.4 Right to Withhold or Cancel Rewards: Sky Links Capital retains absolute discretion to withhold, cancel, or reclaim any Reward where there is evidence or reasonable suspicion of abuse, manipulation, or breach of these Terms and Conditions. All decisions made by the Company in this regard shall be final and binding.

10. MODIFICATION AND TERMINATION

10.1 Sky Links Capital reserves the absolute and unconditional right, at its sole discretion, to amend, modify, suspend, or terminate this Referral Campaign, in whole or in part, at any time and for any reason, without prior notice or liability to any participant. Such changes may include, but are not limited to, alterations to eligibility criteria, reward amounts, campaign duration, or procedural requirements.

10.2 Any amendments or updates to these Terms and Conditions shall become effective immediately upon being published on the official website of Sky Links Capital or disseminated through other formal communication channels (client email notifications, platform announcements). Continued participation in the Campaign following such publication shall constitute acceptance of the revised terms.

10.3 In the event of termination of the Campaign, any reward entitlements that have already been validly accrued by participants prior to the effective date of termination, provided all corresponding conditions and eligibility requirements have been met, shall be honored by Sky Links Capital in accordance with the original Terms and Conditions in force at the time of accrual.

10.4 Sky Links Capital shall not be held liable for any direct or indirect loss, cost, damage, or inconvenience resulting from any modification, suspension, or termination of the Campaign, including but not limited to the loss of potential or anticipated rewards.

11. LIABILITY DISCLAIMER

11.1 To the maximum extent permitted by applicable law, Sky Links Capital, its affiliates, directors, officers, employees, and agents shall not be held liable for any loss, damage, claim, cost, or expense of any kind, whether direct, indirect, consequential, incidental, or special, arising out of or in connection with:

a) participation in or inability to participate in the Referral Campaign;

- b) technical errors, system failures, internet connectivity issues, delays, or interruptions in platform access or service delivery;
- c) errors or omissions in tracking referrals or disbursing Rewards;
- d) delayed, withheld, or failed Reward payments due to force majeure events, regulatory restrictions, compliance verification processes, or any other circumstances beyond the reasonable control of Sky Links Capital.

11.2 By participating in this Campaign, each participant (whether a Referrer or Referred Friend) agrees to fully indemnify, defend, and hold harmless Sky Links Capital, its parent entities, subsidiaries, affiliates, and their respective officers, directors, employees, agents, and representatives from and against any and all claims, liabilities, damages, losses, costs, or expenses (including reasonable legal fees) arising out of or related to:

- a) any breach of these Terms and Conditions by the participant;
- b) the participant's violation of applicable laws or regulations;
- c) any fraudulent, misleading, or abusive conduct in relation to the Campaign.

11.3 Sky Links Capital makes no representations or warranties, express or implied, regarding the availability, reliability, or accuracy of any aspect of the Referral Campaign, and disclaims any implied warranties of merchantability or fitness for a particular purpose.

12. DISPUTE RESOLUTION

12.1 Any dispute, grievance, or claim arising out of or in connection with this Referral Campaign shall first be submitted in writing by the concerned party to Sky Links Capital through its official Complaint Handling Procedure. The Company shall endeavor to investigate and address such matters in good faith and provide a written resolution within a reasonable timeframe.

12.2 The decision rendered by Sky Links Capital pursuant to its internal Complaint Handling Procedure shall be considered final and binding in respect of this Campaign, which is purely promotional and discretionary in nature. Participation in the Campaign constitutes acceptance of this provision.

12.3 In the unlikely event that the matter cannot be resolved internally to the satisfaction of all parties, and provided that the nature of the dispute falls outside the discretionary scope of the Campaign, the matter may be referred to the competent authority having jurisdiction in accordance with applicable laws and regulations. However, both parties shall make all reasonable efforts to resolve any disputes amicably before escalating to external channels.

13.1 This Campaign and its Terms and Conditions shall be governed by and construed in accordance with the applicable laws, rules, and regulations of the jurisdiction in which the Referred Friend's live trading account is maintained with Sky Links Capital or its affiliated entities.

13.2 Participants expressly agree that any dispute, controversy, or claim arising out of or in connection with this Campaign shall not be submitted to any court or judicial authority unless legally required by a competent regulator. Instead, such matters shall be resolved through Sky Links Capital's internal complaints and dispute resolution procedures as outlined in Clause 11.

13.3 The jurisdictional laws governing the customer's trading account, as stated in the relevant account opening documentation or client agreement, shall apply to any matter arising from this Campaign, including dispute resolution, compliance oversight, and enforcement of rights or obligations.

13.4 By participating in this Campaign, the Referrer and Referred Friend acknowledge and accept that they shall be bound by the laws and regulations applicable to the jurisdiction of the trading account, and that such jurisdiction shall have exclusive authority over any regulatory interpretation or administrative determination.
